Bids shall be submitted in a sealed envelope clearly marked "2018 Neosho County Lubricant Bid" to avoid premature opening of the bid. Failure to submit a sealed bid as requested may cause the bid to not be considered during official opening. Sealed bids clearly marked as set forth herein shall be mailed or personally delivered to the Neosho County Clerk, 100 South Main Street, P.O. Box 138, Erie, Kansas 66733-0138. Sealed bids will be accepted until 4:00 p.m. CST, on the 18th day of January, 2018. Bids not submitted pursuant to this procedure may be rejected. All bids received after the stated date and time will be returned unopened to the vendor.
