\$4.00	For second page and each additional page or fraction thereof
\$20.00	Recording town plats, for each page

\$2.00	For second page & each additional page or fraction thereof of release or assignment of real estate mortgage
\$5.00	For each additional Book/page of release or assignment of real estate mortgage
\$1.00	Certification of any instrument of record
\$20.00	Filing Federal Tax Lien Notice (includes \$15.00 UCC fee)
\$20.00	Federal Tax Lien Release

\$15.00	Statement of release of all or part of any collateral described in a filed financing statement (up to 10 pages)
\$15.00	Real estate mortgage subject to KSA 84-9-402(6) (Fixture Filing) (up to 10 pages)

\$1.00	Attachments, per page (after first 10 pages)
\$15.00	Written information request, per debtor name

Mortgage Registration Tax calculated at \$.26 cents per hundred dollars of the principal amount of indebtedness.

If the name or names of any signer or notary public are not plainly typed or printed under the signatures, the register of deeds shall charge and collect a fee of \$1.00 in addition to all other fees provided in this schedule. KSA 28-115

If sufficient space is not provided for the necessary recording information and certification on a document, such information shall be placed on additional sheet and such sheet shall be counted as a page.

The document shall be of sufficient legibility to produce a clear and legible reproduction. If a document is judged not to be of sufficient legibility, such document shall be accompanied by an exact copy thereof which shall be of sufficient legibility to produce a clear and legible reproduction and which shall be recorded contemporaneously with the document and shall be counted as additional pages. The Register of Deeds may reject any document which is not of sufficient legibility.
