## **Neosho County Commission Meeting**

The Neosho County Board of Commissioners met in a Regular Session on Tuesday April 13<sup>th</sup>, 2021 in the Commission room of the Neosho County Courthouse in Erie, KS.

**Call to Order:** Commissioner Galemore called meeting to order at 2:00 pm. Those present were Commission Board Chair Nicholas Galemore, Commissioner Gail Klaassen, Commissioner Paul Westhoff, County Clerk Heather Elsworth, and Commission Counselor Seth Jones.

# **PUBLIC COMMENT**

# **DEPARTMENT HEADS REPORT**

HEATHER ELSWORTH/ County Clerk & SYDNEY BALL/ County Treasurer — Update on Payroll. Mrs. Elsworth presented an update on Payroll. The County received a letter from the IRS advising the 1095-C's had not been reported for 2017 which has left the County with a \$156,000 in total for penalty. Mrs. Ball advised the 1095-C's have not been filed for 2019 or 2020 but were filed for 2018. We haven't received any notices yet for 2019 and 2020 is considered late. The State of Kansas is now current.
